TEAMS Anglers may fish this tournament as individuals including fishing from PWCs and kayaks as long as they have VHF communications with COASTGUARD

NOTE Briefing is compulsory and team captains or a nominated team member who is fishing the tournament must register at the office on briefing night, no later than 6.00pm and is to attend and remain until the conclusion of briefing unless prior approval to not attend has been given by the Tournament Convenor.

START FISHING After briefing on Thursday 5 January 2017 **WEIGH IN** 3.00pm - 5.00pm Friday 6 January 2017 3.00pm - 5.00pm Saturday 7 January 2017

Final weigh in time shall be the end of the contest. All fish and catch cards must be at the weigh station by the final weigh in time. (no exceptions).

The skipper of the boat is always responsible for ensuring the area, weather and sea conditions are satisfactory for safe use for the craft they are using.


