Entry Fee: \$40.00 (for all 6 months)

Entry fee covers the entry of all the six named species and must be paid no later **Entry:**

than the day prior to submitting your first fish.

Teams: Anglers may fish this tournament as individuals including fishing from land, PWCs

and kayaks as long as they have comms with Coastguard or a support vessel.

Fishing Area: Fish must be caught within TSFC sponsors grid (NZ Chart 54 modified).

Random access permitted (boats may launch from anywhere)

Fish must be caught in accordance with TSFC Club, NZSFC and IGFA rules. **Rules:**

Measure only tournament - fish may be kept or released, fish must be measured in

accordance with TSFC measure rules.

Any species can be measured any month to contribute to anglers

'overall combined length.'

Anglers may only have one qualifying fish, per species at any one time.

Bigger fish may replace smaller fish (if caught)

Prizes:

Sweepstake and Ian Milburn Trophy, 1st – 3rd. Monthly prize for longest nominated species for the month. If not caught this prize will be drawn. Final 'Overall Combined Length' Sweepstake paid 70%, 20% and \$10%

respectively for 1st-3rd combined length (across all species, only 1 of each species)
