Billfish- Blue, Black & Striped Marlin and broadbill (min 90kg)
Tuna All Species (min 10kg), Mahi Mahi (min 5kg), Shortbilled Spearfish (min 10kg).

captains or a nominated team member who is fishing the tournament must register at briefing no later than 6.30pm and is to attend and remain until the conclusion of briefing unless prior approval to not attend has been given by

the tournament convenor.

Start fishing- After briefing Thursday 30th March 2023

Fishing area- Chart 54 (modified) random access rule applies. Access to/ from the fishing

area can be from anywhere in chart 54 (modified)

Weigh in- 4.00pm-5.00pm Friday, Saturday and Sunday.

Final weigh in time shall be at the end of the contest. All fish and catch cards must

be at the weigh station by the final weigh in time (No execptions)

Prizegiving- 6.30pm Sunday 2nd April 2023.
